## **BLOXWICH ACADEMY**

Bloxwich Academy is part of an inter-Local Authority Co-ordinated Admission Scheme  
All dates referred to within this document are in line with this scheme

### **Year 7 Admission**

Walsall Council's online application process will open in September 2019  
Closing date for the submission of applications is 31<sup>st</sup> October 2019  
Notification date – 1<sup>st</sup> March 2020 (or next working day if 1<sup>st</sup> March is not a working day)

### **Reception Admission**

Walsall Council's online application process will open in November 2019  
Closing date for the submission of applications is 15<sup>th</sup> January 2020  
Notification date – 16<sup>th</sup> April 2020 (or next working day if 16<sup>th</sup> April is not a working day)

The school, as its own Admission Authority, is required to consult on admission arrangements every seven years unless there has been a change to the criteria.  
Once the consultation process has taken place determined arrangements are forwarded to consultees.

It should be noted that where a child meets the admission criteria of two or more schools named in their application then they will be allocated a place at the highest ranked of these schools.

**For admission to Sixth Form, applications should be made directly to Bloxwich Academy.**

**ADMISSION ARRANGEMENTS 2020-2021**

Bloxwich Academy is an all through 3 – 18 Academy with 1105 pupils. The school's admission policy is in accordance with the guidelines below:

**Entry into Reception (September 2020)**

Primary Admission round will open November 2019 to parents of children in nursery (and Year 2 of other Walsall Infant Schools).

Closing Date for return – 15<sup>th</sup> January 2020

Published Admission Number in Reception is 60

**Entry into Year 7 September 2020 and Reception 2020**

Pupils will be admitted without reference to ability, aptitude, race or religion. Children in Year 6 in the primary phase will automatically transfer to Year 7 of the secondary phase without the need to apply for a place. Parents of children not attending Year 6 at the school will need to submit an application to their home local authority, the closing date for secondary applications is 31<sup>st</sup> October 2019. Additional places are available for new pupils. The Published Admission Number in 2020 will be 150 for the secondary site and the Published Admission Number for the primary site will be 60.

Where applications for admission exceed the number of places available, the following criteria will be applied, in the order set out below:

**1. Children in Public Care (looked after children) and previously looked after children**

Definition: children who are in the care of the local authority or provided with accommodation by the local authority and previously looked after children who ceased to be looked after because they were adopted or became subject to a residence order or special guardianship order.

**2. Where a child has an older sibling currently attending the school when the application is made and who will be still attending the school in Years 8 – 11 in September of the relevant year. Siblings of Sixth Form students qualify for a sibling claim.**

Definition: a child who resides at the same address as the child for whom a place is being requested and is one of the following:

- A brother or sister sharing the same parents
- Half brother or sister sharing one common parent
- Step brother or sister (i.e. related by parent's marriage)
- Any other child for whom it can be demonstrated that he or she is residing permanently at the same address (e.g. under the terms of a residency order)

**3. Where there are essential medical or social grounds for admitting the child**

Definition: relevant medical or social grounds that show that attendance at the school is essential and supported in writing by a medical practitioner or social worker. Requests for such consideration will be subject to verification by Governing Body.

#### **4. Children of Staff employed at The Academy**

**Where a member of staff (\*\*) has been employed at The Academy for two or more years at the time at which the application for admission is made/or the member of staff is recruited to fill a vacant post for which there is a demonstrable skill shortage.**

**\*\* All full time teaching staff**

**All full time support staff – (defined as those on a 37 hour week and above contract)**

**The definition does not include contract staff. If service has been ‘in house’ and is subsequently ‘contracted out’ children of staff will no longer be eligible for priority admission under this criterion.**

#### **5. Proximity of the child’s home to the school, with those living nearest being accorded the higher priority, the distance being measured in a straight line**

Definition of home address: the home address of the child is considered to be the permanent residence of a child in a residential property when the place is offered. The address must be the child’s only or main residence and is either owned by the child’s parent, parents or guardian or leased to or rented by the child’s parent, parents or guardian under lease or written rental agreement of not less than six months duration

Distance will be measured in a straight line from the centre point of the home address to the centre point of the school, using the Local Authority’s computerised measuring system, with those living closer to the school receiving the higher priority

#### **Waiting List Policy (Year 7 and Reception Intake)**

Until 31<sup>st</sup> August 2020 parents may enquire about their child’s position on the Waiting List by contacting the Admissions and Pupil Place Planning Team on 01922 652585. From 1<sup>st</sup> September 2020 the waiting list will be maintained by the school and parents should make enquiries by contacting Bloxwich Academy Admissions on 01922 710257 for secondary admissions and 01922 710226 for primary admissions.

From 1<sup>st</sup> September 2020 parents wishing their child/ren to be placed on the Waiting List should contact Bloxwich Academy Admissions in writing to make their requests.

#### **Siblings**

Siblings of Sixth Form students qualify for a sibling claim.

#### **In-Year Admissions**

Applications for in-year admission (age groups other than the normal year of entry) must be made to Bloxwich Academy Admissions.

#### **Admission to Nursery Place**

Every 3 and 4-year-old in Walsall is entitled to 15 hours free early years education through a number of providers. Please apply to Bloxwich Academy, Bloxwich Lane site for details of Nursery admissions.

#### **Appeals**

Parents whose children are refused admission to the school have the right of appeal to an independent appeal panel. The necessary forms and information should be obtained from the Clerk to the Appeal Panel, Bloxwich Academy, Leamore Lane, Bloxwich, Walsall, WS2 7NR to whom completed forms are returned. Please mark the envelope ADMISSION – APPEAL.

Appeals in respect of Year 7 intake for September 2020 should be lodged by Friday 24th April 2020.

### **Late Applications (Year 6 – Year 7 transfer)**

A late application is an application form received after the published closing date. Late applications will normally be considered for places after applications that were received by the closing date. Late applicants may be less likely to be offered a place at the school.

When places are offered, applications received by the closing date and valid late applications (see below) will be considered first.

### **Late applications received before the notification date (before places are offered):**

Applications received by the closing date and valid late applications (see below) will take priority when places are offered.

Valid late applications can only be considered if the application form is received within four weeks of the closing date.

### **Explanation of valid late applications:**

There are limited circumstances when a late application may be categorised as a valid late application and considered together with those applications that were received by the closing date.

Subject to verification by the Director of Children’s Services, Walsall Council, a late application may be considered as a valid late application where:

- The family were unable to complete an application form before the closing date because they moved into the Borough of Walsall after the issue of application forms.
- OR
- The family were unable to comply with the admissions timetable because of exceptional circumstances which prevented the application arriving on time – the circumstances must be given in writing and attached to the application form.

### **Applications received after the Notification Date (after places are offered):**

Where the school is over-subscribed an application for a place which is received after places have been offered will be added to the school’s waiting list in admission criteria order.

### **Minimum entry requirements for Year 12 for September 2020**

Pupils will be considered for entry into Year 12 based upon their academic attainment and/or individual subject grade criteria and the availability and suitability of courses at Bloxwich Academy.

Bloxwich Academy’s minimum entry requirements for Post 16 studies are as follows:

The minimum entry requirement for admission into Year 12 is grade 4 - 9 at GCSE (or equivalent) in 4 different GCSE subjects **AND** English (either Language or Literature) **AND** Maths requiring Grade 5 at GCSE for entry. (There are also course suitability and individual subject availability criteria requirements for some courses, on request.)

Pupils refused a place in Year 12 are entitled to appeal to an independent appeal panel

To progress from Year 12 to Year 13, students must meet the academic selection criteria we set. Students will be notified of these criteria prior to them taking up their places in September of Year 12.
