### **APPEAL APPLICATION**

Appeal applications should be made in writing to the Clerk to the Appeals Panel at Bloxwich Primary Academy or by telephoning the school on 01922 710226. Please ask for an Admission Appeals form. You must give written reasons for your appeal.

Once an appeal has been lodged, appellants will receive at least 10 working days' notice of their appeal hearing date (although appellants can waive their right to this).

If you would like to submit additional evidence prior to the appeal hearing, you should ensure that this is submitted to the Appeals Clerk at least 7 working days prior to the appeal hearing. Decision letters will be sent within 5 working days following the hearing.

### **ADMISSION APPEALS FOR CHILDREN DUE TO START RECEPTION CLASS IN SEPTEMBER 2026**

**National Offer Day (Primary)** – Thursday 16<sup>th</sup> April 2026

**Deadline for Lodging Appeals** – 3pm on Friday 15<sup>th</sup> May 2026

Appeals received by Friday 15<sup>th</sup> May 2026 will be heard during June/July 2026

Please note it may not be possible to hear appeals received after Friday 15<sup>th</sup> May 2026 (late appeals) before the start of the new school year in September 2026. Appeals are not heard during school holidays.

### **Please Note**

The statutory limit on class sizes in infant classes restricts circumstances in which an Appeal Panel may uphold an appeal where the admission would exceed the class size limit of 30 pupils with a single qualified teacher. For Reception, Year 1 and Year 2, an Appeal Panel can only uphold an appeal if it is satisfied that:

Your child would have been offered a place if the published admission arrangements had been properly implemented

Or

Your child would have been offered a place if the arrangements had not been contrary to the school admissions code and legislation

Or

The decision was not one which a reasonable admission authority would make in the circumstances of the case

Please note that while you may talk about personal factors at an infant class appeal hearing, the Appeal Panel cannot take personal factors into account unless they are relevant to one of the three points above.
